Pool Reservations

The fenced pool area may be reserved for parties subject to the following rules:

1. Any member desiring to have a party in the swimming pool area must make reservations with the Association Manager. Reservations will be accepted no less than 14 days in advance and no more than 60 days in advance. All deposit fees are due when reservation is made.
2. The deposit will be refunded if:
 - a. There are no damages as a result of the party.
 - b. The party sponsor does not leave the party prior to the scheduled ending time.
 - c. Lifeguards are paid the amount agreed upon.
 - d. Attendance does not exceed the number indicated on the reservation form.
 - e. The party is cancelled at least 24 hours in advance.
3. Certified lifeguards must be employed for the duration of any swimming party. After receipt of your reservation, the Association Manager will arrange for the lifeguards.
4. Lifeline Aquatics will contact you if your party size requires additional lifeguard staff. The additional lifeguards will be paid for by the party sponsor and payment must be received at least 12 days in advance of the event.
5. The lifeguards have authority over conduct at the party.
6. The host member(s) must be present for the duration of the party.

I will assure that all persons attending the party will abide by the Scofield Phase VIII Residential Owner Association Pool Rules given to owners upon receipt of your pool keycard. Additional copies of the rules are available upon request. Glassware is not permitted inside the fenced area. No Alcohol is ever permitted in the pool area. All persons attending the party will be respectful of other HOA members using the pool area.
